Hyannis is the largest of the seven villages in the town of Barnstable, Massachusetts. It is the commercial and transportation hub of Cape Cod. Hyannis is a major tourist destination and the primary ferry boat and general aviation link for passngers and freight to Nantucket Island. Hyannis also provides secondary passenger access to the island of Martha's Vineyard, with the primary passenger access to Martha's Vineyard being located in Woods Hole, a village in the nearby town of Falmouth. Due to its large natural harbor, Hyannis is the largest recreational boating and second largest commercial fishing port on Cape Cod, behind only Provincetown. The village was named after Iyannough, a sachem of the Cummaquid tribe.
