The NCWM S&T Committee had many block and individual items to discuss during the open hearing. Details on each agenda item can be found on the NCWM website under Publication 16. The results of the voting session are listed below:

Consent Calendar voting items:

Block 6: LPG-1 S.2.1. Vapor Elimination

Block 6: CLM-3 S.2.1. Vapor Elimination

Block 6: CDL-3 S.2.1. Vapor Elimination

Water Meters: WTR-2 S.2.1. Provision for Sealing and Table S.2.1. Categories of Device and Methods of Sealing

The Block 6 items consisted of language alignment pertaining to LPG. WTR-2 was an editorial change to strike the Nonretroactive dates within the table and add a Nonretroactive date following the table.

103rd NCWM Annual Meeting S&T Report (cont'd) Individual voting items:

Vehicle Tank Meters: VTM-1 S.3. Diversion of Measured Liquid and UR 2.6 Clearing the Discharge Hose NIST OWM identified some required editorial and technical changes. To move the safety aspects of the item forward, it was split in to two parts. Part 1 was voted on and passed. Part 2 will be carried over for the 2019 meeting. Please see Publication 16 for more details.

Scales: SCL-6 Deactivation of a "d" Resolution Liquid Measuring Devices LMD-2 S.1.6.7. Recorded Representations, S.1.6.8. Recorded Representations for Transactions Where a Post-Delivery Discount(s) is Provided and UR.3.4. Printed Ticket

The submitter provided clarification that the proposed retroactive date specified beneath paragraph UR3.4. should be changed to Nonretroactive. The committee amended the proposal accordingly.

The committee heard numerous comments from the submitters and others recommending this item be assigned to a work group.

The committee heard numerous comments in support of an assigned status on the item and the need for the submitter to provide comparison test data to support its claim that the WIM vehicle scale system can comply with the tolerances specified in the proposal. The task group will remain intact.

Professional Development Committee

The PDC had very successful meeting and enthusiastic working sessions at the annual NCWM meeting in Tulsa Oklahoma. Many subjects were addressed and moved forward as a result of the Committee work and follow up collaboration with the Board of Directors and NCWM leadership.

Professional Development Committee (cont'd)

EDU-1 Professional Certification Program

Beginning September 1, the NCWM will offer new online Basic Competency Exams. The NCWM must implement proctoring to have the Professional Certification Program accredited. Additionally, many states are interested in using the new Basic Competency Exams for licensing/registering service agents. These states will be demand that the integrity of these exams be safeguarded. State directors have been sent the requirements for proctoring as well as documents to be signed and sent to the NCWM to register recognized proctors.

The Committee met during the Annual Meeting to respond to the Board's concerns regarding the length of the exam exit survey and necessity of specific questions. Significant work was done to improve the exit survey.

EDU-2 | Training

Ms. Tina Butcher (NIST/OWM) reported on training provided over federal fiscal year 17 (Oct 2016-Sept 2017) and plans for FY 18 and FY 19. OWM will simplify this in the future by reporting on calendar year. A complete list of upcoming OWM training events is available on the calendar of events on the OWM website. She also noted OWM is working with the regions to coordinate training which will be offered concurrent to the regional meetings.

EDU-3 | Instructor Improvement

Ms. Tina Butcher (NIST/OWM) announced NIST is unable to renew the training grant at this time, due to budget limitations. This will curtail the use of state trainers in some of the NIST training classes.

EDU-4 | Recommended Topics for Conference Training

This year's Annual Meeting training event was a visit of the Magellan Midstream Partners pipeline terminal, including a tour, as well as a classroom session explaining how pipelines work. The Committee was pleased with the high level of participation and will consider similar training events for future meetings.

PMT-1 | Safety Awareness

The NCWM website has a multitude of safety resources on the site. The report of the Safety Task Force is a good resource and it will be posted on the website with the Safety Tool Kit expected by the end of August. The Committee was pleased to learn the Board decided to upgrade the Safety Work Group to a subcommittee reporting to the PDC to continue this very valuable effort.
